



Information on your application for a therapeutical sojourn

Dear applicant,

Thank you for your interest in Peter Maffay Foundation! This newsletter provides details on our foundation and on how to develop your application.

Peter Maffay Foundation includes the following facilities:

- Tabaluga House Finca Ca'n Llompart (Pollença, Mallorca) – max. 14 persons
- Tabaluga House on the shore of Lake Maisinger (Jägersbrunn, near Starnberg) – max. 12 persons
- Tabaluga House in Rodeș (Rodeș/Radeln, Transylvania, Romania) – max. 16 persons
- Tabaluga House in Duderstadt (Duderstadt, near Göttingen) - max. 16 persons
- Sidan Youth Hostel (Mayrhofen, Zillertal, Austria) - max. 14 persons
- "Sir Robert Baden Powell" sailboat – max. 14 persons (max. = children/teenagers, including carers!)

We provide sojourns in these facilities for children/teenagers marked by physical/mental suffering.

As you can imagine, these projects entail considerable costs (house maintenance, personnel, repairs etc.). For each visitor, this means daily costs of €120-130 per person, per day, depending on the location. Depending on the financial situation of our applicants, this amount may be partly or even fully covered, when the net income does not exceed a certain threshold. Also, some sojourns may be subsidised by sponsors or you may find a co-sponsor yourself. We provide consultation on such matters to find an acceptable solution for all those involved.

The meals costs are €3 or €5 per day and per person (depending on the location), but this contribution may be fully eliminated for very difficult cases – upon request.

In order to accept your application for a sojourn in our facilities, we need the following:

- Detailed information on your organisation (e.g., flyer, leaflet, website etc.)
- Operating permit, namely administrative documents authorising your institution
- Group age structure and description of problems (2-3 sentences)
- Description of the existential situation of the children under supervision (brief CVs, 2 - 3 sentences per child). All data are protected and shall be used only for internal purposes!
- Contact partners, namely group carers (min. 3 carers; please indicate professional competence)
- Sojourn purpose and activities – your views
- Financial plan, in terms of your contribution to financing
- Sojourn period and location (not mandatory for us!)
- In case of approval, we will need proof of health insurance abroad (the health card should indicate the European health insurance number), full names and dates of birth of all participants (e.g., for booking flights)
- Group civil liability insurance

Meals:

Tabaluga House Finca Ca'n Llompart, Tabaluga House in Rodeş, Tabaluga House on the shore of Lake Maisinger and Tabaluga House in Duderstadt are self-sustaining facilities, with well equipped kitchens. The nearby localities provide good shopping facilities (supermarkets or mini-shops).

Sidan Youth Hostel in Mayrhofen and Sir Robert sailboat provide meals as well.

Vehicles:

Tabaluga House at Ca'n Llompart farm, Tabaluga House on the shore of Lake Maisinger and Tabaluga House in Rodeş have each a minibus of 9 seats, which can be made available for guests for the amount of €300 per sojourn. Each user should make a cash deposit of €300, to be reimbursed after the vehicle is returned, if there are no objections or damages. The minibus shall be returned against an acceptance report. Upon request (financial difficulties), the minibus fee may be eliminated partly or even fully. Other facilities do not have vehicles available.

Impressions:

Sustainability is key in all our facilities. Therefore, we think it's highly important to further document all sojourns. For this purpose, please send us your impressions, together with pictures, immediately after your sojourn. With your permission, the report may be published on our website or by the Tabaluga Journal of Peter Maffay Foundation, but we need this information first and foremost for our internal documentation. All information is highly confidential. Also, please indicate after about six months if you notice any changes in the participants, any particularities related to the sojourn with us.

In order to facilitate the dossier evaluation stage, please make sure your application is complete before submitting it. As the applications we receive every year exceed our capacity, we thank you in advance for understanding that we cannot accept all applications. We collect all applications until October each year, for the following year. In December, the submission year, we shall inform you on the eligibility of your application.
